a. Dog Park Survey

Optics to question, are people going to look at \$25 going to have an impact? Should we increase the amount per gift card? This would mean fewer cards to give out. Concern of putting the gift card promotion on social media is you may have people seeking it who are not in need but just want a gift card.

Contact Astoria to determine who or how many people have reached out to inquire about relief for their fees. Put up something on the website with an email asking them to contact us if you know someone in need or you yourself are in need. No board members could directly benefit from this.
