Two tenders received thus far, a bit of confusion on coverage areas and hoping two more bids coming in. Some confusion on the planters, how many and where they are located.

c) Insurance Claim – Fence

The board decided on a payout for the hail damage, we discovered 5 panels cracked, we do not know date of loss and we do not know cause of loss. BFL is concerned even if we put in one or multiple claims, they are worried Intact will drop the Board and not insure the Board anymore. Part of this is the loss history we have and effective could put us in peril of getting insurance.

Questions: what is the cost to repair each panel?

- A. \$7850 total \$40,000 + GST. We have paid \$50,000 already so we would need to see if he would provide a refund of \$50,000. Annette will confirm on the \$10,000. We need to understand the period of time for time of loss and cause of loss. Investigate repairability on the wall for the smaller cracks.
- d) Community Sections with no HOA (20%) Email from the councillor's office and the City of Calgary is unable to assist in anyway in getting the 20% covered under the HOA.

e) Median Update

There was an increase in cost due to changes in requirements from the City of Calgary. The cost has increased to \$23,050 + GST.
